CITIZENS MILITARY TRAINING CAMP

1. Organization.

Records of the United States Army on file at the headquarters of the Seventh Corps Area show that a camp was held at the site of Camp Joseph T. Robinson (then Camp Pike) in 1921, but there are no details of this nor any subsequent camps until 1931. In the summer of 1931, and annually since, the War Department has held Citizens Military Training Camps there.

The buildings, improvements, fixtures and utilities located upon and within the Camp Pike Military Reservation were purchased by the State of Arkansas from the United States Government, under contract of sale dated August 25, 1922, for the use and benefit of the National Guard of the State of Arkansas and for the preservation of the camp. Prior to the year 1931, the Camp Pike Honorary Commission, acting jointly with the Arkansas National Guard, brought Camp Pike to the recognized standard of National Guard Camps, enabling it to be accepted by the United States Government as a camp for C. M. T. C. trainees. The name of Camp Pike was recently changed by order of the War Department to Camp Joseph T. Robinson.

2. Activities of Citizens Military Training Camps.

Recruiting for the C. M. T. C. in Arkansas is carried on by the Army officer in charge of the Organized Reserves within the state, who is also the C. M. T. C. officer for the state.

The C. M. T. C. is conducted by Regular Army officers assigned to duty by the Commanding General of the Seventh Corps Area.

As Camp Joseph T. Robinson is not a Regular Army post with permanent garrison, the Camp Commander, the Executive Officer, a Plans and Training Officer, a Mess Officer, and others must be assigned each year, and arrangements for the camp are made by such individual officers before and after their arrival at the camp. With these Regular Army Officers there are also sent regular army troops,

usually from Fort Crook, Nebraska, to prepare the camp, and do the clerical and other work. All actual training is carried on by three groups of Reserve Officers, one group for each of three ten-day periods of the camp. This method of training the C. M. T. C. by Reserve Officers serves the twofold purpose of training the Reserve Officers as well as the C. M. T. C. trainees.

The current mobilization plan for the United States provides that in the event of war, three reserve divisions shall be mobilized at Camp Joseph T. Robinson and that it will be a field artillery training center.

3. Expenditures.

Beginning with the opening of the first C. M. T. Camp at Camp Pike in 1931 and including the 1937 Camp, a total expenditure of \$249,582 has been made by the federal government from War Department funds. Such expenditure was limited to transportation, subsistence pay of personnel and trainces, etc., and did not include the cost of camp upkeep or other expenses which were borne by the Arkansas National Guard. The average annual expenditure for the C. M. T. C. in Arkansas over a seven year period amounts to \$35,654.

Table 11 lists the 1937 Citizens Military. Training Corps personnel by grade and branch of service and Table 12 shows War Department annual expenditures on this camp for seven years ending June 30, 1937.

CIVILIAN CONSERVATION CORPS

Creation and Personnel

The Civilian Conservation Corps has in operation in the State of Arkansas at the present time 37 work camps located throughout the state, 11 in the national forests, 11 in soil conservation projects, seven on private land projects, five in state parks, and three on biological survey projects. Each camp is supervised by one commanding officer, one company officer, medical officer or contract physician, and an educational advisor. The Arkansas District is commanded by a Regular Army officer located at Little Rock, Arkansas. There are nine department heads directly responsible to the District Commander as follows: Executive Officer, Adjutant, Inspector, Finance, Quartermaster, Medical, Welfare, Signal, and Educational.

The active officer personnel of the District includes four members of the Regular Army and 146 Reserve Officers, a total of 150 officers. There are also approximately 128 civilian employees, both full and part time. The enrolled personnel comprises 6,459 juniors and 579 veterans.

Those who administer the C. C. C. endeavor, through the Educational Department, to eliminate illiteracy among the enrollees. "Job training" is given much attention. Training is also given in courses of business administration, shorthand and typing in an effort to

Tables 13a, b and c list by grade and branch of service the officers of the Civilian Conservation Corps in Arkansas and Table 14 shows the expenditures annually to April 30, 1937. The expenditures in Arkansas for the fiscal year ending June 30, 1937 for Regular Army and Reserve Officer pay is estimated at \$475,000.
